Fund Training Expenses

- Level I Trainee: \$3000 tuition assistance, \$5000 stipend
- Level II Trainee: \$7500 stipend
- Financial support to organization to increase access to clinical supervisors



Qualified Workforce

- Complete culturally relevant curriculum
- Actively develop skills
- Demonstrate competencies
- Expanded provider network
- Registered Apprenticeship model increases trainee' wages based on achievements

Certification Training



- Training pathways target certification goals
- Must first complete Level I training
- Courses meet certification training requirements for BHA-I, BHA-II, CT, CDC-I, CDC-II*

Accessible Training



- 10-weeks per session
- Most courses are distance-delivered & self-paced
- Full-time= ~3hrs/wk of training activities
 - Level I = ~12 months; Level II = ~18 months
- Part-Time= ~1.5hrs/wk of training activities

Level I Training

Ethics & Consent (6), Confidentiality & Privacy (6), Intro to Behavioral Health (24), Intro to Counseling (12), Intro to Documentation (12), Survey of Community Resources & Case Management (8), Working with Diverse Populations (12), Intro to Group Counseling (8), Crisis Intervention (16), HIV/AIDS & Blood-Borne Pathogens (8). **Total cost of tuition: \$3100.**

Level II Training

Orientation to Village-based Behavioral Health Services (8), Community Approach to Promoting Behavioral Health (8), Family Systems I (16), Recovery, Health, Wellness, & Balance (8), Psychophysiology & Behavioral Health (16), Intro to Co-Occurring Disorders (8), Tobacco Dependency Treatment (8), DSM Practice Application (12), Advance Interviewing Skills (16), ASAM Practice Application (12), Case Studies & Clinical Case Management (8), Traditional Health Based Practices (8), Intermediate Therapeutic Groups Counseling (16), Applied Crisis Management (8), Community Development Approach to Prevention (12), Family Systems II (16). **Total cost of tuition: \$5000.**

* Training requirements for BHA certification include one additional course (General Orientation [28 hours]) and CDC-II certification includes two additional courses (Special Issues in BH Services [16 hours] and Documentation and Quality Assurance [12 hours]) beyond that which is required for Level I and II training pathways for this grant. These courses are available for an additional fee.
