Requirements for Renewal for CHA/Ps, continued

On January 13, 2022, the Community Health Aide Certification Board approved the following change to **Section 2.50.200 Requirements for Renewal**:

Sec. 2.50.200. Requirements for Renewal. (amendments are underlined)

(a) A certified community health aide, community health practitioner, dental health aide, or behavioral health aide or practitioner applying for certificate renewal shall:

(1) apply on a form provided by the Board;

(2) pay the application fees required by the Board;

(3) provide evidence satisfactory to the Board that the applicant has met the continuing education requirements of the Board;

(4) provide evidence satisfactory to the Board that the applicant continues to demonstrate the practical professional competencies required for the level of certification sought;

(A) for a community health aide or community health practitioner, a re-entry evaluation, following CHAP guidelines, will be conducted for an applicant who has not been employed in direct patient care for a minimum of 80 hours with a minimum of 30 patient encounters in the six months prior to submission of the application;

(B) for a community health aide or community health practitioner, a biennial clinical competency evaluation will be conducted

(5) continue to meet the requirements of chapter 2 [certification of CHA/Ps, DHAs, & BHAs]; and

(6) if seeking recertification as a community health practitioner, no less often than once every six years, the individual must resatisfy the requirements of section 2.20.500 [CHP training & education requirements]; or

(7) if seeking recertification as a dental health aide therapist practitioner, no less often than once every six years, the individual must re-satisfy the requirements of section 2.30.700(3) and (4) [DHATP training & education requirements].

WHAT THIS CHANGE MEANS

As a Community Health Aide (CHA/P) progresses through basic training, there is a standardized process to document clinical competence as they learn and hone their clinical skills. However, outside of the basic training structure, there is not a standardized process to document clinical competence for any:

- a) CHA/P seeking certification unable to complete at least one basic training session within the preceding two years
- b) CHA/P seeking certification who completed basic training more than two years prior to recertification, and
- c) CHP seeking recertification with completion of preceptorship more than two years prior to recertification.

While each THO is required to maintain the competency of their health aides, and attest to this fact when submitting renewal certification paperwork to the board, there is significant variability in how this competency is assessed and documented across organizations. To ensure that all certified CHA/Ps receive a standardized clinical competency evaluation every two years prior to recertification, the board worked closely with stakeholders to create a formal process known as the Biennial Skills Evaluation. The biennial skills evaluation will require the CHA/P to demonstrate, under supervision, their competency to perform a list of required skills for their corresponding certification level(s) and maintain documented completion of this assessment.

EXAMPLES OF WHEN A BIENNIAL SKILLS EVALUATION IS REQUIRED

I have a health aide that recently completed a basic training session and field training and is ready to apply for the next level. Do they have to complete an additional biennial competency evaluation prior to applying for their certification?

No. As long as they have completed all post session learning needs within the two-year recertification period, they do not need to complete a biennial competency evaluation.

Requirements for Renewal for CHA/Ps, continued

I have a health aide who is certified as a CHA III in 2021, but has not been able to attend Session IV. Will they need to complete a biennial competency evaluation if they cannot complete the Session IV training prior to recertification?

Yes. Anyone, including a CHA/P who remains at one certification level for more than 2 years or a CHP whose last preceptorship was completed more than two years ago, who needs to renew their CHAPCB certification, must complete a formal biennial skills evaluation as part of the recertification process.

WHEN DOES THIS CHANGE GO INTO EFFECT?

You will have one year to implement these changes within your Community Health Aide Program. Any CHA/P renewing their board certification during the 2022 calendar year will not an all in one application form for initial, renewal be required to complete a biennial skills evaluation, but it is recommended you start the

process as soon as possible. Beginning January 2023, the Biennial Skills Evaluation will be a requirement for certification.

The CHAPCB Application for CHA/P Certification, Form 99-01, was revised 01/13/2022 to reflect the Standards changes to include Re-entry and Biennial Skills language. The application is now and change in level applications.

Dental Health Aide Therapist Practitioner ------

A Dental Health Aide Therapist with six consecutive years of practicing as a certified DHAT may have the ability to apply to become a certified Dental Health Aide Therapist Practitioner (DHATP).

The benefits of becoming a DHATP are:

- Direct supervision requirements will only need to be done every six years instead of every two.
- Recognition that DHAT has proven over time to be a trusted member of the healthcare team who reliably provides high quality dental care to their patients.

The requirements to become a DHATP are:

- Earn a DHATP Credential from the Alaska Dental Therapy Education Program (ADTEP) Has to be renewed every six years
- Maintain current certification from the Community Health Aide Certification Board (CHAPCB)
 - Has to be renewed every two years

The goal of the DHATP certification is to recognize Dental Health Aide Therapists who have proven over time that they are reliably providing competent care for their patients and lowering their supervision requirements to allow them to practice more efficiently, while putting other safety mechanisms in place to ensure that these providers continue to deliver high quality dental health care to Alaska residents accessing dental care through Tribal Health Organizations.

BHA Curriculum Revision Announcement and Grandfathering Plan



The Community Health Aide Program Certification Board (CHAPCB), created the BHA curriculum through a statewide collaboration with members of the behavioral health and substance use community in 2008. The curriculum was created to develop BHA knowledge and skills at four levels of service provision and was designed to build upon the skill of the previous level of practice. In 2020 the Behavioral Health Academic Review Committee (BHARC) undertook the task of reviewing and updating the curriculum and submitted a revision request to the CHAPCB to amend the BHA curriculum. The table below outlines the curriculum changes which resulted in an increase in hours for BHA I and BHA II and a reduction in hours for BHA III and BHA/P.

BHARC recommended, and CHAPCB approved, a two year grandfathering period to ensure all students have adequate time to complete their training. The grandfathering period started on November 1, 2021 and will continue through November 1, 2023.

BHAs currently seeking certification at the BHA I and II levels will be grandfathered under the old contact hour requirements until November 1, 2023. If application for certification is made after the November 1, 2023 deadline, BHAs will be required to take the additional hours of training at their level of certification.

BHAs seeking certification at the BHA III and P levels have already experienced a reduction in the course contact hour requirement.

Reasons to get checked for Colorectal Cancer

You are Alaska Native.

Alaska Native people are twice as likely to get colorectal cancer compared to Alaska Whites.

2X as high



You are 40 years or older.

Over 90% of men and women who get colorectal cancer are over the age of 50. Alaska Native people should start screening at age 40. A screening is a test where they look for cancer.

A family member has had colorectal cancer.

You are more likely to get colorectal cancer if a family member has had it. Ask your family about their health history. Talk to your provider about when you should start colorectal cancer screening.





Colorectal screenings prevent cancer and save lives.

Screenings can help find small growths, called polyps, that can be removed before they turn into cancer.

Colorectal cancer often has no symptoms.

Cancer can be in your body even if you feel good. Screenings can find the cancer early, when it is easier to treat.



Getting Colorectal Cancer Screenings Back on the Books

The COVID-19 pandemic has meant that many of us have put off essential screening tests that check for cancer. March was Colorectal Cancer Awareness Month. This is a good time to remind your patients, friends and family about the importance of colorectal cancer screening.

Alaska Native people are twice as likely to get diagnosed with colorectal cancer. The good news is that **colorectal cancer can be prevented** through screening and early detection.

Alaska Native men and women should get checked for colorectal cancer starting at age 40, or earlier if they have family history. Non-Alaska Native people should start screening at age 45. And if someone is having symptoms, such as blood in the stool (feces) or abdominal pain they should be checked to rule out colorectal cancer.

There are many safe and effective screening tests available, including colonoscopy as well as stool tests that can be done at home. These tests are an important part of staying healthy. For those getting colonoscopies, hospitals have put measures in place to reduce the risk of transmitting COVID-19 infection to keep patients safe and ensure continued health.

Despite the challenges we face during the pandemic, regular colorectal cancer screening is important. Talk to your patients about screening and the screening options available. If their colonoscopy was postponed or canceled, help them get rescheduled. You can also get a list of the patients due for screening in your community to remind them about screening and help them figure out a screening plan. Encourage your friends and family to get screened when they are due.
